

## **ANGLICAN CARE DIOCESAN SERVICES ORDINANCE 2012**

**AN ORDINANCE** to establish **ANGLICAN CARE**, in the Diocese of Newcastle as the universal provider for social caring services for the aged and infirm within the Diocese of Newcastle and to repeal the Storm Village Constitution Ordinance 1990 as amended and the Storm Retirement Village (Incorporation) Ordinance 1998

**BE IT ENACTED** by the Diocesan Council exercising powers delegated to Bishop, Clergy and Laity meeting in accordance with the Synod (Delegation of Powers) Ordinance 2009 as follows:

### **PREAMBLE**

#### **WHEREAS**

Anglican Care has been established for the provision of social caring services for the aged and infirm within the Diocese of Newcastle.

Storm Village has been established for the provision of social caring services for the aged and infirm in the City of Taree and provides accommodation and amenities on land at Taree and Cundletown for that purpose.

It is expedient for the purpose of managing, governing and controlling the provision of social caring services for the aged and infirm within the Diocese of Newcastle that the provision of such services be merged under the name of Anglican Care.

#### **REPEAL**

1. The following Ordinances are hereby repealed provided that such repeal shall not affect or invalidate any act done under the Ordinances or any right privilege obligation or liability acquired accrued or incurred thereunder and the trusts created by the Ordinances shall be valid and continue in the manner and extent provided -  
  
(a) The Storm Village Constitution Ordinance 1990 (as amended) (b)  
Storm Retirement Village Incorporation Ordinance 1998

#### **DEFINITIONS**

2. **Anglican Care** means the social caring agency established by the Diocese of Newcastle to promote and conduct activities within Australia and particularly within the Diocese consistent with the objects established

**Diocese** means the Diocese of Newcastle

**Storm Village** means the social caring agency established by the Diocese of Newcastle known as the Storm Retirement Village to provide accommodation and

services for aged people within the City of Taree consistent with the objects established

***Storm Village Ordinances*** means The Storm Village Constitution Ordinance 1990 (as amended) and Storm Retirement Village Incorporation Ordinance 1998

#### **POWERS AND DUTIES**

3. The Board of Anglican Care shall have the powers and duties of managing, governing and controlling the accommodation and services of Storm Village previously held by the Board of the Storm Village.

#### **SCOPE**

4. The provision of this Ordinance shall apply to all trust property held for the purpose of the provision of aged care by virtue of the Storm Village Ordinances including trust property pursuant to the will of the late Valerie Hughes of Taree.

#### **TRANSITIONAL**

5. All offices established and all persons elected or appointed or holding office under the Storm Village Ordinances shall continue and be subject to the provisions of those Ordinances as they had been in force at the time such offices were established and such persons were elected or appointed as if they had been established elected or appointed respectively thereunder.

#### **EFFECTIVE DATE**

6. This Ordinance shall come into effect on the 1 day of July 2013

#### **SHORT TITLE**

7. This Ordinance may be cited as the ***Anglican Care Diocesan Services Ordinance 2012.***
