AN ORDINANCE to vary the sum of trusts unallocated in the **Schedule One** for the Parish of Morpeth.

AND WHEREAS the Parish of Morpeth have consented to the variation of the trusts set out in the **Schedule One** be applied for Ministry purposes in the Parish of Morpeth as determined by the Parish Council.

BE IT ENACTED by the Bishop and Diocesan Council of the Diocese of Newcastle pursuant to the **Synod (Delegation of Powers) Ordinance 2009** and every other power hereunto enabling as follows:

- 1. The sums set out in **Schedule One** hereto shall be applied for Ministry purposes in the Parish of Morpeth upon the following terms and conditions.
- 2. The interest arising upon such trust shall be applied for Ministry in the Parish of Morpeth as determined by the Parish Council.
- 3. The Permanent Trust shall be, "The Morpeth Ministry Trust".
- 4. Any interest shall be paid as determined by the Trustees. Such sums shall be paid as to 80% thereof to the Parish Council and the remaining 20% of the interest thereof shall be capitalised for a period of fifty years from the date of Assent of this Ordinance.
- 5. The Synod directs the Trustees in fifty years to review the objects of this Ordinance and to make such further recommendations to the Synod as to the further capitilisation if necessary of such income.

Short Title

This Ordinance may be cited as the "Morpeth Ministry Trust Ordinance 2010."
