

**NEWCASTLE ANGLICAN CHURCH REDRESS CORPORATION APPOINTMENT AND
AUTHORISATION ORDINANCE 2019**

AN ORDINANCE to amend the Newcastle Anglican Church Redress Corporation Ordinance 2018.

BE IT THEREFORE Ordained by the Diocesan Council as follows: -

PART 1 – THE ORDINANCE

Short Title

1. This Ordinance may be cited as the ***Newcastle Anglican Church Redress Corporation Appointment and Authorisation Ordinance 2019***.

Amendment

2. The Newcastle Anglican Church Redress Corporation Ordinance 2018 is amended by:

- (a) by the deletion of clause 6 and the insertion of a new clause 6 as follows:

6.1 This Ordinance shall not be repealed and no amendments shall be made to the Ordinance (in accordance with **clause 6.2**) without the prior written authorisation of the Anglican Representative (National Redress Scheme) Limited (**ARNRSL**).

6.2 This Ordinance may only be amended in accordance with the Bodies Corporate Act, which as at the date of this Ordinance requires:

- (a) the passing of an amending ordinance by the Synod or by any board, committee, council or body of persons exercising the delegated authority of the Synod;
 - (b) the assent of the Bishop;
 - (c) the certification of that amending ordinance by the Bishop; and
 - (d) a copy of the amending ordinance certified by the Bishop to be filed in the Office of the Registrar-General.
- (b) by the insertion of a new section 20.1A in the following terms:

20.1A The NACRC:

- (a) is authorised by the Diocese to make application to the Anglican Representative (National Redress Scheme) Limited (**ARNRSL**) for the Diocese to become a member of the Anglican Participating Group of the ARNRSL;
- (b) is appointed by the Diocese to act for and on behalf of the Diocese with respect to all matters relating to the Diocese's membership of the Anglican Participating Group that is represented by the ARNRSL;
- (c) shall, as the Diocese's representative of the Anglican Participating Group of the ARNRSL and otherwise on behalf of the Diocese, comply with all of the Diocese's obligations as a member of the Anglican Participating Group of the ARNRSL under the ARNRSL's Constitution (and particularly By Law 7.2).

I HEREBY CERTIFY the Ordinance as printed is in accordance with the Ordinance as reported.
