

ORDINANCES INTERPRETATION AND PUBLICATION ORDINANCE AMENDMENT ORDINANCE 2020

AN ORDINANCE to revise the process of publishing ordinances.

BE IT THEREFORE Ordained by the Diocesan Council of the Diocese of Newcastle as follows:

BACKGROUND

This Ordinance updates the administrative processes associated with the publication of ordinances

PART 1 – PRELIMINARY

Short Title

1. This Ordinance may be cited for all purposes as the ***Ordinances Interpretation and Publication Ordinance Amendment Ordinance 2020***.

PART 2 – OPERATIVE PART

2. The Ordinance Interpretation and Publication Ordinance 2011 is amended by
 - a. the repeal of repeal sections 12, 13, and 18;
 - b. in section 14 replacing the words “the Ordinance Committee” with the words “the Diocesan Chief Executive”;
 - c. in section 17 repealing all the words and replacing them with the words “In revising an Ordinance, a legislative history note must be made in such manner and form as is consistent with the manner and form applied by the Parliament of New South Wales”;
 - d. in section 19 repealing all the words in section 19 and replacing them with the words “Any revised Ordinance shall be deemed publishable on the date determined by the Diocesan Chief Executive”.
 - e. In section 23
 - i. replacing the words “Diocesan Chief Executive” with the words “the Bishop or the Diocesan Chief Executive”; and
 - ii. replacing the words “he or she” with the words “the Diocesan Chief Executive”
 - f. in section 26
 - i. repealing the words “to the Ordinance Committee or”; and
 - ii. repealing the words “and the Ordinance Committee”.
