

## CEY MINISTRIES ORDINANCE 2011

**WHEREAS** various people and bodies within the Diocese of Newcastle contributed funds on trust for the purpose of purchasing and maintaining a venue for providing ministry to and with young people in the Diocese, and

**WHEREAS** there have been various changes in the governance of ministry to and with young people since the initial trust was established, and

**WHEREAS** the funds, land and buildings of this initial trust are now held on trust by the Trustees of Church Property in a Trust known as the Yondaio Trust,

**WHEREAS** it is expedient to confirm the disposition of the existing Trusts,

**WHEREAS** it is expedient to ensure effective utilization of these funds together with the effective governance of ministry to and with young people in parishes, schools and across the Diocese, and

**WHEREAS** it is expedient to confirm that the work of CEY Ministries includes supporting the member schools of the Newcastle Anglican Schools Corporation, Added 2015

**BE IT THEREFORE ORDAINED AND RULED** by the Diocesan Council in accordance with the Synod (Delegation of Powers) Ordinance 2009 and exercising the Powers vested in it by the Anglican Church of Australia Trust Property Act 1917, as follows

### PART 1 – PRELIMINARY

#### Short Title

- This Ordinance may be cited as the ***CEY Ministries Ordinance 2011***.

#### Repeal

- The Children Special Religious Education and Youth Ministry Ordinance 2002 is hereby repealed provided that any action undertaken in accordance with that Ordinance shall have effect as if it were undertaken in accordance with this Ordinance unless this Ordinance shall prescribe a contrary intention.

#### Definitions

- In this Ordinance unless the context or subject matter otherwise provides, the word:

<b>Bishop</b>	means the Bishop of Diocese of Newcastle or a person acting as Commissary of the Bishop or Administrator of the Diocese in the event of vacancy in the See.
<b>Diocesan Council</b>	means the Bishop acting with the advice and consent of the Diocesan Council.
<b>Trustees</b>	means the Trustees of Church Property for the Diocese of Newcastle.

## PART 2 – OPERATIVE PART

### Purpose of CEY Ministries

4. CEY Ministries exists for the purpose of nurturing, encouraging, facilitating and resourcing ministry to for by and with children, young people and their families within the Diocese of Newcastle.

### Yondaio Trust

5. By reason of the circumstances subsequent to the creation of the trusts to which the real and personal property described in the attached Schedule is subject it has become inexpedient to carry out or observe such trusts therefore the said property is now held in trust for the purposes of CEY Ministries.
6. The Trustees may do all that is necessary and expedient to ensure the proper management of the Trust. These powers include but are not limited to
  - a. ensuring the capitalisation of income on the trust in accordance with any general or specific policy established by Diocesan Council;
  - b. making available to the Diocesan Council such income from the Trust as will enable it to meet its budget;
  - c. entering a private contract for the sale of any land and buildings for such sum or sums and upon such terms and conditions as may be determined by the Diocesan Council;
  - d. executing and doing all necessary deeds conveyances transfers assurances and other instruments acts and things for giving full and complete effect to the provisions of this ordinance;
  - e. holding the money arising from any property sale or sales, less the costs associated with such sale or sales, for the purpose of CEY Ministries;
  - f. pooling existing accounts and funds.
  - g. applying the income and capital of the trust to ensure the ministry to children, young people and their families through member schools of the Newcastle Anglican Schools Corporation is maintained in the event that security given by the Trustees is called upon by any lender to a member school of the Newcastle Anglican Schools Corporation for borrowing by that school approved by the Newcastle Anglican Schools Corporation.
